I. INSTRUCTIONS

The Vehicle Entry Pass (income-based) entitles the recipient to day-use parking. **The cost of the pass is \$5.00** (price subject to change). The pass is not transferable and may be revoked at any time if misused.

To apply, complete Sections II, III and IV of this application. Eligibility must be verified each year to qualify.
Application, a dated eligibility letter with your name, and payment must be presented in person or by mail.

III. ELIGIBILITY REQUIREMENTS (Check one)

- Sonoma County School Free Meal Program participation by presenting a current copy of the eligibility letter from child’s school. Eligibility includes the FREE school meal program for the current academic school year, and not reduced priced meals.
- Supplemental Social Security Insurance [SSI] or Social Security Disability Insurance [SSDI] verification by presenting a copy of SSI Payment Decision or SSDI Award Certificate.
- Sonoma County Regional Parks eligibility letter from one of the following: SonomaWORKS/CalWORKS, CalFresh Letter is automatically sent from Sonoma County Human Services via US Mail to qualifying recipients based on income level. Recipient names and address must appear on letter. Date of letter determines pass expiration date.
- Sonoma County Regional Parks eligibility letter from Sonoma County Community Health Clinics participating in this program. An eligibility letter will be automatically be provided to qualifying recipients.

Terms and Conditions:

- The pass may be renewed each year with proof of current eligibility.
- One pass per household is permitted at the same address.
- The pass is valid for the use of the pass owner and spouse/domestic partner.
- The pass is only for residents of Sonoma County.
- The pass is valid for vehicle day use only at all Sonoma County Regional Parks and trails. You may use the pass any day of the week, including holidays.
- The pass is not valid for camping or special events.
- The pass is not valid for resale.
- The pass is valid unless revoked and is non-transferable. All sales are final. No refunds or replacement will be made for any reason including loss, theft or park closures.
- The pass may be used for one passenger vehicle of nine persons or less where day use fees are collected. Oversized vehicle fees will not be assessed; however, not all parks can accommodate oversized vehicles.
- Display the pass on your vehicle’s rear mirror or dashboard where it is visible through the windshield.
