The Vehicle Entry Pass (income-based) entitles its bearer to day-use parking only. The cost of this pass is \$5.00 (price subject to change). The pass is not transferable and may be revoked at any time for misuse.

To apply, complete Sections II, III and IV of this application. Eligibility must be verified each year to qualify. Application, photo identification, and payment must be presented in person.

Vehicle Entry Pass Application Terms and Conditions

Terms and Conditions:

- The pass must be renewed each year and is valid for the use of the pass owner and spouse or registered domestic partner only.
- The pass is for residents of Sonoma County only.
- The pass is valid for vehicle day use only at all Sonoma County Regional Parks and trails. You may use the pass any day of the week, including holidays.
- The pass is not valid for camping or special events.
- The pass is not valid for resale.
- The pass is valid unless revoked and is non-transferable. ALL SALES ARE FINAL. No refunds or replacements will be made for any reason including, but not limited to, loss, theft or park closures.

Required Identification:

- The pass holder is required to present a valid state-issued driver license or other suitable photo identification.

Day Use:

- Display the pass on your vehicle's rearview mirror or dashboard so it is clearly visible through the windshield, with the date punch facing the front.
- The pass may be used for one passenger vehicle with a capacity of nine persons or less where vehicle day use fee is collected. Oversized vehicle fees will not be assessed; however, not all parks can accommodate oversized vehicles.
