B. PUBLIC HOIST:

1. Equipment Loading and Off-Loading

- a. Permanent Berthers: You may unload and load equipment free of charge with a two-hour time limit.
- b. Transient and Non-Berthers: A charge of \$15.00 per 15 minutes will apply for all loading and unloading.

2. Seafood Off-Loading

Including, but not limited to salmon, crab, albacore, swordfish, rock cod, prawns, drag boat caught. Permanent Berthers: \$15.00 minimum fee for use of hoist; first 125 lbs. of fish or one fish box and 300 lbs. of crab offloaded with no offloading charge, thereafter, crab \$0.10 per lb.; salmon \$0.10 per lb.; all other species \$0.05 per lb.

<u>Transient Vessels:</u> \$15.00 minimum fee for use of hoist, plus offloading charges: crab \$0.20 per lb.; salmon \$0.20 per lb.; all other species \$0.10 per lb.

C. SEAFOOD SALES:

No Charge Must possess a current California Department of Fish and Wildlife Wholesaler License and comply with all California Department of Fish and Wildlife codes. Must possess a current weighmaster license and provide a certified scale for selling seafood.

- **D. EMERGENCY BILGE PUMP OUT:** \$80.00 each incident
- E. LATE PAYMENTS: Payment due 1st of every month, late on 6th of month and delinquent on the 15th of the month. Late payments are assessed a 10% late fee. If payment is past 30 days delinquent, the boat owner may be charged at the transient rate and may be liable for any legal fees incurred during the collection and/or lien process.
- **F. RETURNED CHECK CHARGE:** \$35.00 for the first instance; legal action will be taken on future returns.

G. IMPOUNDMENT, ABANDONMENT:

A \$500.00 fee may be charged, plus any expenses incurred in connection with action taken, including but not limited to attorney's fees.

- H. **LOCATOR FEE, FAILURE TO REGISTER:** A \$75.00 fee may be charged for individuals who fail to register with Marina Management by the end of normal business hours and will be applied in situations where a boat owner must be located.
- I. KEY DEPOSITS: A \$50.00 deposit will be charged for each key issued to a permanent berth holder, refundable upon return of key to the Marina Office WITHIN 30 DAYS following termination of berthing agreement.

J. ELECTRICAL SUBMETER CHARGES:

Permanent Tenants: Commercial and Recreational

Electric submeter charges per month will be at PG&E prevailing rates for the type of service and adjusted for time of year; minimum charge is \$9.68.

K. DAMAGE TO DOCK BOXES, SLIPS, OR EQUIPMENT:

Cost of repairs plus staff time will be charged for any damages to Marina property.
